#### **OPEN SESSION**

#### Ethics awareness and conflict of interest

Mr. Holloway read the statement required by G.S. § 138A-15(e) on ethics awareness and conflicts of interest. No board members indicated that they had any potential or actual conflicts.

## Administrative hearings

Malik Freeman, file #37852, was given notice to appear but did not attend his hearing.

#### Felony hearings

Joshua Johnson of Central Carolina Community College presented cases for individuals who were incarcerated with the Department of Adult Correction. Adrienne Bridges of the Department of Adult Correction was present and offered information about the individuals' criminal history.

Mr. Johnson presented information to the board about the criminal history and rehabilitation efforts of James A. Parker, file #38723. Mr. Johnson answered questions from board members and staff.

Richard G. Dayson, file #53797, was given notice to appear but did not attend his hearing.

## Mobile barber shop proposal

Edward Deans had proposed changes to regulations for mobile barber shops. He recommended that the board allow trailers or pull-behind units to be used as barber shops.

Mr. Holloway offered background to the topic and explained why initially the board didn't allow trailers. He also shared his concerns about trailers. Mr. Beal also shared those concerns but suggested that the board review other states' practices. Ms. Rolka had concerns about the sanitation conditions.

Mr. Holloway suggested that the board include further discussion of the topic in the development of a new strategic plan. The board's ad hoc committee for the strategic plan would further consider the Mr. Deans's proposal.

## Barber school hours proposal

Mario Little had submitted a proposal to the board related to barber school hours. However, Mr. Little was unable to attend the meeting, and Mr. Holloway delayed discussion of the proposal until the next board meeting.

## Hearing determination

Mr. Holloway made a motion to offer James A. Parker a consent order with standard terms and conditions, including five years of probation. Mr. Burkhart seconded the motion, which passed 8-0.
